

E31 - DEPENDENT KITAS

(FAMILY KITAS)

Dependent family members of KITAS and long-stay visa holders (including Golden and Remote Worker Visas) are allowed to reside in Indonesia as dependents of their sponsoring family member.

E31B - Spousal of KITAS holder

This visa is for the spouse of a foreign national with any type of KITAS. It is valid for the same duration as the primary KITAS holder but does not allow the spouse to work.

Length of Stay

- 6 months, 1 year, 2 years.

With this visa, you CAN :

- Live in Indonesia.
- Travel to and from Indonesia as many times you want.

With this visa, you CAN NOT :

- Stay in Indonesia after your visa expires.
- Sell goods or services.
- Receive compensation, wages, or any similar from individuals or companies in Indonesia.

Visa Validity

- This visa must be used within 90 days from the date of issue.

Document Requirements

- Passport that is valid for at least 6 (six) months.
- A recent color photograph.
- Marriage certificate translated into Indonesian by a sworn translator.
- A personal bank statement showing a minimum equivalent amount of USD \$2000. The statement must cover the last 3 months and include your name, the date, and the account balance.
- Valid visa/Limited Stay Permit (ITAS)/Permanent Stay Permit (ITAP) of the legitimate husband or wife.

E31E - Child of Kitas holder

This visa is for the dependent child (under 18 years old) of a foreign national with any type of KITAS. It is valid for the same duration as the primary KITAS holder.

Length of Stay

- 6 months, 1 year, 2 years.

With this visa, you CAN :

- Live in Indonesia.
- Travel to and from Indonesia as many times you want.

With this visa, you CAN NOT :

- Stay in Indonesia after your visa expires.

Visa Validity

- This visa must be used within 90 days from the date of issue.

Document Requirements

- Passport that is valid for at least 6 (six) months.
- A recent color photograph.
- A personal bank statement showing a minimum equivalent amount of USD \$2000. The statement must cover the last 3 months and include your name, the date, and the account balance.
- Birth certificate translated into Indonesian by a sworn translator*
- Marriage book or parents' marriage certificate translated into Indonesian*
- Valid Stay Permit (ITAS)/Permanent Stay Permit (ITAP) of the parents
- Proof of medical condition or proof of guardianship translated into Indonesian by a sworn translator* (specifically for individuals above 18 years old with humanitarian/health considerations).
- Single entry or Multiple entry E-visa

E31H - Parent of KITAS holder

This visa is for the parent of a foreign national with any type of KITAS. It is valid for the same duration as the primary KITAS holder but does not allow the parent to work.

Length of Stay

- 6 months, 1 year, 2 years.

With this visa, you CAN :

- Live in Indonesia.
- Travel to and from Indonesia as many times you want.

With this visa, you CAN NOT :

- Stay in Indonesia after your visa expires.
- Sell goods or services.
- Receive compensation, wages, or any similar from individuals or companies in Indonesia.

Visa Validity

- This visa must be used within 90 days from the date of issue.

Document Requirements

- Passport that is valid for at least 6 (six) months.
- A recent color photograph.
- A personal bank statement showing a minimum equivalent amount of USD \$2000. The statement must cover the last 3 months and include your name, the date, and the account balance.
- The child's birth certificate has been translated into Indonesian by a sworn translator*;
- Child's valid Visa/Limited Stay Permit (ITAS)/Permanent Stay Permit (ITAP).
- Single entry or Multiple entry E-visa
